
# Statield Moraling

# 1. Approve minutes of 28<sup>th</sup> August 2015

#### 4 **Progress on the NDP Document**

PW reported that John Cornwell advised that WBC recommendation to omit specific percentage figures in the narrative and justification sections should be adopted. It was agreed that the numbers should be removed and broad descriptive statements should be used to indicate the level of support such as significant, substantial and overwhelming. Similar adjectives for disagreed will be used.

It was agreed the evidence base should be in the form of a contents list as an appendix in the NDP main document including the web address pointing to the online detailed evidence. A sentence should be included in the introduction highlighting the evidence base and pointing to the contents list in the appendix which should include the web address.

# 5. Feedback from meetings with Bell Cornwell (BC) together with Item 11 'Agenda for meeting with Englefield' on 7<sup>th</sup> September 2015

The initial proposals for the Site Design Brief submitted by Bell Cornwell, and the one prepared by TA Fisher were discussed. The proposals have several, broadly similar features. A number of points were identified that should be discussed at the meeting with Englefield on Monday 7<sup>th</sup> September 2015. These are listed in the appendix.

#### 6. Meeting with St John's School

The Steering Group was briefed on the meeting with St John's School, 3<sup>rd</sup> September 2015 which had been very positive. The school was updated on the status of the NDP and that Englefield had agreed to the allocation of space for a new school in the Site Design Brief. The head indicated that the diocese was willing to consider funding a new school. It was confirmed that the land of the present school is owned by the diocese and that it does not revert to Englefield estate if the school vacate the site. The school were invited to attend the Site Design public meeting on the 21<sup>st</sup> September 2015.

## 7. Site Design - Public Meeting

The date for the open event was confirmed as Monday 21<sup>st</sup> September 2015. The doors will open at 7.30 pm allowing 30 minutes for an exhibition of the discussion draft design. This will be followed be a presentation and depending on the number of attendees a Q&A session if there is a large attendance or round table discussions if the numbers are low enough to make this feasible.

It was agreed that the exhibition should comprise:

- 1. 1 or 2 A1 displays of the policies and key feature points in the brief to Bell Cornwell and TA Fisher
- 2. A1 displays of the suggested site design plus photographs to enable visitors to visualise the design
- 3. A 'mood' board o consisting of 1 or 2 A1 displays to indicate the style of the site.

The exhibition material will be duplicated to create two presentations.

Consideration of the flyer was postponed to the next Steering Group meeting.

The meeting approved a reply to Mr West who had suggested that land by the station be considered for development.

- The design of the roundabout as a feature
- Access arrangements
- Shape of housing density (Bell Cornwell areas vs Fishers wave)
- Inclusion of more public rights of way (e.g. DM suggestions)
- Inclusion of mood board/photos
- Is a 2 storey surgery practical/acceptable building
- Confirm that green space would be maintained by WBC
- Planting of additional trees along the boundaries
- Extent of TPOs, just some trees or all of trees on western edge
- Review drainage plans
- Outline design for v. high density area
- Include Fisher central walk idea.
